\*A horse placed fourth in Group/Graded since 1990 does not thereby qualify for Black-type. Horses placed fourth in such races in 1989 or before remain qualified for Black-type (Gr. 1 fourths only in 1989).

For all mares a full breeding-record is shown. 4th and 5th dams may be included if space allows.

#### **Racing Careers**

#### 8. Keep and Removal of Horses After Sale

Purchasers must make arrangements for the keep and attendance of their Lots from the fall of the hammer. Subject to the Conditions of Sale in general and Condition 7 in particular Purchasers (and Vendors of unsold Lots) are requested to comply with any arrangements regarding removal of Lots from Fairyhouse which may appear in the catalogue. #### 12. Broodmares

#### 12.1 Rhinopneumonitis

The following notice is included at the request of the Thoroughbred Breeders' Association (TBA): Mares in late pregnancy which have come from a sale constitute a possible risk to the stud where the mare is sent, since from the fifth month of pregnancy onwards there is a possibility that abortion due to Rhinopneumonitis may occur. Attention is drawn to the revised recommendations from the Thoroughbred Breeders' Association that mares from stud farms where Rhinopneumonitis Virus Abortion has occurred during the previous season should be foaled in isolation.

#### 12.2 Isolation of Broodmares

In accordance with TBA recommendations, all mares returning from the sales should be isolated from in-foal mares.

#### 13. Value Added Tax ('VAT')

#### 13.1 Lots for Export to Great Britain

Where lots are purchased for immediate export to Great Britain, the purchase may be zerorated for VAT purposes provided that Tattersalls Ireland are supplied with satisfactory proof of export from the Republic of Ireland by the Purchaser or his shipping agent. UK import VAT at the prevailing rate could arise on the importation of the horse back into the UK.Independent third-party advice should be sought to ensure that UK import VAT is avoided where possible.

#### 13.2 Lots for Export to Northern Ireland

Where lots are purchased for export to Northern Ireland, the purchase may be zero-rated for VAT purposes provided the horse is dispatched from Republic of Ireland within 3 months of sale, the invoice is made out to a person registered for VAT in Northern Ireland, the VAT number is lodged with Tattersalls Ireland and Tattersalls Ireland are supplied with a satisfactory proof of movement from the Republic of Ireland.

#### 13.3 Lots for Export to other EU Country

Where lots are purchased for export to another EU country, the purchase may be zero-rated for VAT purposes provided the horse is dispatched from Republic of Ireland within 3 months of sale, the invoice is made out to a person registered for VAT in the European Union ('EU'), the VAT number is lodged with Tattersalls Ireland and Tattersalls Ireland are supplied with a satisfactory proof of movement from the Republic of Ireland.

#### 13.4 Lots for Export Outside the EU

Where Lots are purchased for immediate export outside the European Union ('EU'), the purchase may be zero-rated for VAT purposes provided that Tattersalls Ireland are supplied with a satisfactory proof of export from the EU by the Purchaser or his shipping agent.

#### 13.5 Lots Purchased by Irish Residents

The Reduced Rate of VAT (currently 13.5%) applies to the supply of live horses other than those normally intended for use in agricultural production. The Livestock Rate (currently 4.8%) continues to apply to the supply of live horses normally intended for use in agricultural production. Accordingly, the Livestock Rate (currently 4.8%) only applies to those horses that are supplied to a farmer. In practical terms, therefore, in order for the supply of a horse to qualify for the application of the Livestock Rate (currently 4.8%) a purchaser must provide a written declaration to the VAT accountable supplier (Tattersalls Ireland Ltd) that he or she is a farmer (as defined in section 2 of the VAT Consolidation Act 2010) with details of his or her name, address and PPS/VAT registration number. A copy of the required declaration is available from the Accounts Office. #### 14. Payment for Purchases (Condition of Sale 4)

Passport (Microchip No. should be verified). Up-to-date flu vaccinations – see below (vaccinations not required for yearlings in the February Sale only). Intra-Community health certificate dated within 14 days.

### HORSES IN TRAINING BROKEN/UNBROKEN (INC. 2 YEAR OLDS)

Passport (Microchip No. should be verified). Up-to-date flu vaccinations – see below. Soundness for Racing Certificate (dated within 14 days) where applicable. (N.B. to be completed on Tattersalls Ireland issued veterinary certificates). Fillies Examination Certificate (dated within 14 days) only required for fillies 3 years old and over being sold as potential brood mares. Contagious Equine Metritus (C.E.M.) certificate required if offered with Fillies examination certificate (see below). Intra-Community health certificate dated within 14 days.

#### FILLIES OUT OF TRAINING

Passport (Microchip No. should be verified). Up-to-date vaccinations – see below. Fillies examination certificate (dated within 14 days) only required for fillies 3 years old and over being sold as potential brood mares. Contagious Equine Metritus (C.E.M.) certificate dated within 30 days – see below. Intra-Community health certificate dated within 14 days.

#### **BROODMARES INC. MAIDEN MARES**

Broodmare Passport (Microchip No. should be verified). Once a mare is in foal she must be named and also registered with Weatherbys as a "broodmare". No flu vaccinations are required. Covering certificate. Pregnancy certificate (dated within 21 days) Contagious Equine Metritus (C.E.M.) certificate dated within 30 days – see helow.

EVA certificate dated within 30 days. Intra-Community health certificate dated within 14 days. Vaccination of all pregnant broodmares against Equine Herpes Virus (EHV – 1, EHV-4).All pregnant mares will be required to have been vaccinated against EHV in the 5th, 7th and 9th month of pregnancy and details recorded on the mare's passport. Mares of less than 9 months gestation at the

time of sale would only require certification of vaccination at 5 and 7 months. Mares of less than 7 months gestation at the time of sale would only require certification of vaccination at 5 months. Pregnant mares may not be admitted to Tattersalls Ireland premises without EHV Vaccination certificate.

#### BARREN BROODMARES

Broodmare Passport (Microchip No. should be verified). No flu vaccinations are required. Contagious Equine Metritus (C.E.M.) certificate dated within 30 days – see below. Intra-Community health certificate dated within 14 days.

#### STALLIONS

Passport (Microchip No. should be verified). **No** flu vaccinations are required. Soundness for breeding certificate (dated within 14 days). Contagious Equine Metritus (C.E.M.) certificate dated within 30 days – see below. Intra-Community health certificate dated within 14 days.

#### CONTAGIOUS EQUINE METRITIS (C.E.M.)

One swab of Clitoral Fossa to be taken within 30 days of sale - to be negative for C.E.M. **N.B.** It takes approximately 7 days to obtain a C.E.M. certificate.

Please note the below new rules with regard to vaccinations which have been implemented from 1st January 2022. These new rules will apply to all horses attending a Tattersalls Ireland Sale (except foals in the November NH Sale the November Flat Foal Sale and the Yearling section of the February NH Sale)

#### FLU VACCINATIONS (NEW RULES)

The Vaccinations against Equine Influenza are required to be administered as follows: the primary vaccinations (consisting of two injections) must be given not less than 21 days nor more than 60 days apart. A booster injection must be given not less than 120 days and not more than 180 days after the second injection of the primary vaccination. Thereafter, booster injections must be given not more that six months apart. Please note where vaccinations are found not to be up to date a fee will apply.
